Reservations & Payment

A 10% non-refundable deposit on rooms is required for acceptance of booking.

Total room charges and total catering costs are required to be paid one (1) month prior to check in.

Catering numbers: Refund will be made if notification in writing is given one (1) week prior to event of reduction in catering numbers.

If account is not paid as requested the Motel reserves the right to rebook room(s).

Insurance

Airport International Motel will take all necessary care but accepts no responsibility for damage or loss of merchandise left on premises prior to, during or after the group's stay. Organisers should arrange own insurance.

Noise

The management has the right to determine whether noise from music or other sources are excessive.

The management reserves the right to request reduction and if request is not complied with, eviction of group may occur.

Basis of Agreement

Performance of this agreement is contingent on the ability of the Airport International Motel to complete same, and is subject to labour troubles, disputes, strikes or picketing, accidents, government (federal, state or local) requisitions, restriction upon travel, transportation, food, beverage, or supplies; equipment failure, and other causes, whether based on breach of contract, warranty, or otherwise. In no event shall Airport International Motel liability be in excess of the total amount contracted heretofore.

Normal guest terms and conditions will apply to all guests during the length of their stay.

Terms and Conditions

Comfort Inn Airport International Terms and Conditions

- 1. Entry into Motel is conditional upon a signed guest registration form and full accommodation payment on or prior to check in.
- 2. The person named on the booking must be the person to sign the guest registration form, valid photographic identification will need to be produced at the motel on check in.
- 3. Guest must advise the motel if a third person or nominee will check in on their behalf.
- 4. Rates do not include any additional charges, but not limited to; meals, transfers or any incidentals that may occur, inclusive of GST.
- 5. Due to fire regulations, management must be aware of the number of guests in each room. Should the fire alarm be activated, the cost of emergency services attending will be charged to the guests, including GST.
- 6. All rooms are strictly NON-SMOKING.
- 7. All room rates are for 1,2,3 or 4 guests. AUD\$20.00 charge will apply to any extra guests. Children under the age of 12 can stay free of charge, while using existing bedding.
- 8. Standard payments accepted by the motel are Cash, Credit Card (MasterCard, Visa, Amex and Diners). *Please note all Credit Card payments will incur a 2.00% Surcharge.*
- 9. Standard check in time is 2:00pm, Standard check out time is 10:00am. Late check out up to 11.00am is at the discretion of the Motel manager and must be requested the night before check out. Late check out after 11:00am will incur the full rate of one (1) nights' accommodation.
- 10. Guests arriving outside of reception hours, (7:00am to 10:00pm) MUST ring the Motel during reception hours to arrange key collection.
- 11. If in the course of a guests stay, and contributable to any guests or visitors of that room and, any unforeseen expenses that become apparent, the signing guests' credit card will be charged an amount, appropriate to the expense, at a rate determined by the Comfort Inn Airport International.
- 12. In the interest of quiet enjoyment and respect for all guests at the motel, a **no party policy** applies to all guests staying at the property. Guests are expected to be respectful of other guests at all times, and to be quiet between 10:00pm-7:00am. No group congregations in individual guest rooms is permitted or tolerated. Immediate eviction with no refund applies to any breaches of this policy.
- 13. Room degradation (e.g. vomit or bodily waste) will incur a AUD\$200.00 cleaning fee, in addition to any professional floor cleaning charges at cost, plus a daily room tariff equal to the daily tariff that the Motel would charge if the room was available to be let or any other rate that may be agreed by management, in accordance with business demand on the day, until said room has been returned to its saleable condition.
- 14. Cost of repair or replacement for general damage or theft of motel property and any problem sufficient to result in a room being withdrawn from its availability to be let will be borne by guests. In extreme cases, criminal charges will be pursued.
- 15. All pets are strictly forbidden inside Motel and guest rooms.
- 16. Comfort Inn Airport International Motel's staff and management are not responsible for any damages or loss to guests' goods or valuables during their occupancy at the property.
